

 Jewish provider agencies: \$6 Billion



## MONEY FOLLOWS THE PERSON

- Stands on the shoulders of Medicaid
- Gets low-income older adults & people with disabilities back home
- Pays for transition costs (1<sup>st</sup> month's rent, furnishings, housing/services coordinator)
- 44 states; more than 88,000 beneficiaries
- Reduces Medicaid spending (20%)
- September 30, 2016
- December 31, 2018

#### ANCOR is...

#### What is Money Follows the Person?

- First authorized by in 2005 by Pres. Bush and reauthorized in 2010 by Pres. Obama, MFP is designed to:
  - Support Medicaid enrollees who want to transition from nursing facilities back to community-based settings;
  - and developing infrastructure to promote and enhance access to HCBS.



#### Impact of MFP

- About 80,000 people have moved into the setting of their choice.
- At least 47 states have improved access to home and community-based services (HCBS) for people with disabilities and older adults.
  - In FY05, states only spent approximately 37% of their LTSS expenditures on HCBS. According to the most recent data, states now spend over 53% on HCBS.



#### What is the current status of MFP?

- The program expired on September 30, 2016.
- There is not enough funding to sustain the program at current levels. Overall, states had to cut back approximately 40% on their plans submitted to CMS.
- Without additional funding, every state will stop transitioning new individuals this year.
- All states will have exhausted their MFP funding by December 31, 2018.



#### Why do we need MFP to continue?

- Significant variations remain across states and different populations who need HCBS.
  - HCBS accounted for 75% of spending in programs targeting people with developmental disabilities, compared to only 41% of expenditures for programs targeting older people, people with physical disabilities, and people with serious mental illness.
- Over 50,000 nursing home residents said they wanted to talk with someone about leaving their facility, but never received a referral to a local agency that could help them.
- States have learned lessons and can share promising practices with other states.



#### **EMPOWER Care Act**

- H.R. 5306 Rep. Brett Guthrie (R-KY) & Rep. Debbie Dingell (D-MI)
  - Co-sponsors: 27 Republicans, 49 Democrats
  - 1 year reauthorization passed unanimously out of House Energy & Commerce Committee
- S. 2227 Sen. Rob Portman (R-OH) & Sen. Maria Cantwell (D-WA)
  - Co-sponsors: 4 Republicans, 19 Democrats, 1
     Independent
  - Currently in Senate Finance Committee



#### **EMPOWER Care Act improves MFP**

- Reduces how long someone must be in a nursing home before becoming eligible to transition from 90 days to 60 days.
- Enhances the reporting and accountability of MFP funding.
- Requires the federal government to identify and share the most effective state strategies for transitioning beneficiaries from institutional to qualified community settings.



#### **Congressional Outlook**

- Advocates remain optimistic for a one year reauthorization of MFP during Congress' Lame Duck session.
- Possible standalone bill or package of legislation with ACE Kids Act and/or reauthorizing spousal impoverishment provision of ACA.
- Cost for EMPOWER Care is approximately \$450 million over 10 years.
- No payfor is currently identified.

# MFP: TEXAS

- One of the earliest and largest MFP programs in the country
- Helped Texas "rebalance" its long-term services and supports system, shifting more to HCBS
- Achieved 110% of our goals
- Transitioned nearly 12,000 people (through 2016)
   ▶ 4,362 older adults
  - > 4,406 individuals with physical disabilities
  - 2,665 individuals with intellectual or developmental disabilities
