"Long-term services and supports (LTSS) are defined as the services and supports used by individuals of all ages with functional limitations and chronic illnesses who need assistance to perform routine daily activities such as bathing, dressing, preparing meals, and administering medications."

<u>Employer</u>	<u>49%</u>
Non-Group	<u>7%</u>
Medicaid	*19%*
<u>Medicare</u>	14%
Other Public	2%
<u>Uninsured</u>	9%

LTSS is almost entirely provided by Medicaid.

Private insurance and Medicare effectively **do not** cover LTSS.



Home and Community Based Services (HCBS) are LTSS, but not all LTSS are HCBS.

For people with disabilities, access to HCBS is a <u>civil rights</u> <u>issue</u>.

For other populations, HCBS are the preferred kind of LTSS to receive.

The disability community will not support health care reform proposals that harm or do not improve coverage for LTSS.
