**Message to the White House and Congressional Leadership:
Retain NEMT Benefit in “Gap” Health Insurance**

Scores of advocates and stakeholders urge the White House and congressional majority leadership to retain non-emergency medical transportation (NEMT) as a requirement in the gap health care coverage provision of the final Build, Back, Better budget reconciliation package.

The nearly sixty organizations below appeal to the negotiators on the gap health care coverage for the 2 million individuals that reside in the 12 states that have not expanded Medicaid to some of their lowest income residents. Both the Energy and Commerce and the Ways and Means versions of the gap coverage provision require that NEMT be part of the package of benefits. As the lowest cost Medicaid benefit with the highest return on health care cost savings, NEMT is critical to ensure that the newly covered patients have access to their new essential health benefits.
