Background: Reps. Raúl M. Grijalva (D-AZ), Jan Schakowsky (D-IL), and Elissa Slotkin (D-MI) reintroduced the *Supplemental Security Income (SSI) Restoration Act*. Nearly 8 million Americans, over the age of 65 or with significant disabilities, rely on SSI benefits to meet their basic needs. Currently, SSI benefits provide an average income that is below the poverty line.

With the program being largely unchanged since its inception in 1972, the SSI Restoration Act makes critical updates to keep beneficiaries out of poverty. The bill modernizes and improves SSI by streamlining and simplifying the claiming process, expanding the resources and income limits, setting the minimum benefit at 100 percent of the Federal Poverty Level, and eliminating punitive reductions in benefits.

An Urban Institute <u>report highlighted</u> that the SSI Restoration Act would lift approximately 3.3 million people out of poverty and cut the poverty rate among SSI recipients by more than half. It would also target a population experiencing serious economic hardship including children and adults with disabilities, older Americans, people of color, and those likely to develop a disability and meet SSI's strict financial requirements.
