RE: Support for the Think Differently Database Act (H.R. 670/ S. 4174)

Dear Representatives Molinaro and Sherrill and Senators Schmitt and Ossoff:

The undersigned members of the Consortium for Constituents with Disabilities (CCD) Long Term Services and Supports (LTSS) Task Force write in support of the Think Differently Database Act (H.R. 670/S. 4174), bipartisan legislation that would help increase awareness of state caregiving options available for individuals with disabilities.

CCD is the nation's largest coalition of national disability organizations. The LTSS Task Force addresses the services and supports that enable individuals with disabilities of all ages to live in their homes and communities.

Many individuals with disabilities utilize Medicaid-funded Home and Community-Based Services (HCBS) to assist with a wide array of supports, from assistance with their activities of daily living such as bathing, dressing, using the bathroom, getting in and out of bed, and eating, to supporting individuals through skill-building activities to promote independence and community inclusion. States use Medicaid waiver authorities to meet the needs of individuals with disabilities who prefer to receive their long-term care services and supports in their home or community. These services are essential for individuals with disabilities to live, learn, work, and participate in their communities.

In addition to challenges in finding and retaining caregivers, individuals with disabilities often struggle to even know and understand what caregiving options are available in their state. According to the Centers for Medicare and Medicaid Service (CMS), 47 states and DC operate at least one 1915(c) waiver,¹ with more than 250 active HCBS waiver programs nationwide.²

Online information about state caregiving services can be “hard-to-find, confusing, inconsistent, and not consumer-oriented,” as one recent caregiving report found.³

The Think Differently Database Act would help address the challenge many individuals with disabilities face in understanding their caregiving options by requiring the U.S. Department of Health and Human Services to create an online clearinghouse of state caregiving services and programs. This publicly available website would feature eligibility requirements, available services, waitlist duration, and other critical information about state caregiving services, including Medicaid waiver and buy-in programs. The legislation would require that this information be updated periodically and searchable by geographic area.

We support the House-amended version of the legislation that would make this online information relevant to all individuals with disabilities.⁴ Your legislation represents a meaningful step in helping to address the common caregiving challenge of not knowing what caregiving options exist and their eligibility requirements. We support your efforts to advance this important legislation this Congress.
