Dear Chairman Guthrie and Ranking Member Pallone,

The Mental Health Liaison Group ([MHLG](#)), is a coalition of national organizations representing individuals and families experiencing mental health and substance use challenges, mental health and substance use treatment providers, advocates, and other stakeholders committed to strengthening access to high-quality mental and substance use disorder (SUD) care. As trusted leaders in the field of mental health and substance use disorders, we write in support of the Committee's markup of H.R. 2483, the "SUPPORT for Patients and Communities Act of 2025" (SUPPORT Act).

The state of behavioral health in America remains a national crisis, with millions of people across the nation experiencing substance use disorders and one in five people in the country are experiencing a behavioral health condition each year. While we are encouraged by the decline in overdose deaths from their peak in 2021 through our combined commitment to address this epidemic, fentanyl-related deaths remain troublingly high and individuals living with substance use disorder still need our help. Additionally, the co-occurrence of mental health conditions leading to suicide is taking the lives of far too many people in our country, particularly our youth, new mothers, and medically underserved communities.

We appreciate your leadership in continuing the bipartisan support the Committee built in the 118th Congress and the swift passage of H.R. 2483. With our nation's worsening mental health, substance use, and suicide crisis—and far too many people in the nation lack access to lifesaving support and care—we urge the Committee to swiftly pass the final compromised version of the SUPPORT Act into law.

There is no time to waste; Congress must act now to avert preventable deaths due to substance use disorders and mental health conditions. The MHLG has a long history of working in a bipartisan manner on the development, passage and implementation of mental health and SUD legislation, including the SUPPORT Act and many others. We look forward to working with you to further support people living with mental health and substance use challenges including people working in our communities and depending on Medicaid. We stand ready to serve as a resource if there are any questions. Thank you for your consideration of this request.
