Dear Senator Cassidy, Senator Smith, Representative Tonko, and Representative Huizenga:

On behalf of the Mental Health Liaison Group (MHLG), we write today in strong support of your legislation, the *Removing Medicare Mental Health Inpatient Limitations Act* (S.4076) and the *Medicare Mental Health Inpatient Equity Act* (H.R. 4619). MHLG is the largest coalition of national organizations representing individuals and families experiencing mental health and substance use challenges, mental health and substance use treatment providers, advocates, and other stakeholders committed to strengthening access to high-quality care. These important bills will end the discriminatory 190-day lifetime limit for inpatient psychiatric care under Medicare, which disproportionately impacts so many seniors in the country who experience mental illness.

Even though Medicare provides health insurance to nearly 70 million Americans, including millions with a mental health condition, Medicare imposes detrimental barriers to care like limiting people to just 190 days of inpatient psychiatric hospital care over their lifetime. This is discrimination, plain and simple. That is why these bills are so vital to ensuring that our seniors receive adequate and appropriate care for their mental health needs for as long as they need it.

For those who experience serious mental illness, it is exceedingly possible to pass the 190-day limit during one's lifetime. The Medicare Payment Advisory Commission (MedPAC) estimates that as of 2024, nearly 50,000 vulnerable beneficiaries have reached or are nearing this cap. Once they have exhausted 190 days over their lifetime, MedPAC notes that people may have difficulty accessing care because demand for public facilities outstrips supply and private facilities may be less willing to take these patients who lack coverage. For this reason, in 2025, MedPAC recommended that Congress eliminate Medicare's coverage limits on stays in freestanding inpatient psychiatric facilities, as this important legislation does.

MHLG is grateful for your bipartisan leadership on this critical issue. We are pleased to endorse the *Removing Medicare Mental Health Inpatient Limitations Act* and the *Medicare Mental Health Inpatient Equity Act* and are committed to working together towards its swift passage.
