To U.S. General Services Administration:

Re: OMB Control No. 3090-0290; Docket No. 2026-0001; Sequence No. 2, System for Award Management Registration Requirements for Financial Assistance Recipients

We, the undersigned 1,334 organizations, oppose the General Services Administration's proposed changes to the System for Award Management (SAM). If implemented, the proposed changes would harm nonprofits, state and local governments, tribes, and other entities that apply for or receive federal financial assistance, including discretionary, mandatory, block, and formula grants, cooperative agreements, loans, insurance, and direct appropriations. The new requirements could disrupt essential services in communities and states nationwide, including housing, community development, health, education, food, shelter, community services, disaster recovery, and more. These impacts would be felt in every community, but would cause the most harm to Black, Latino, Asian American and Pacific Islander, and Indigenous people; women; LGBTQ+ people; people with disabilities; immigrants; and other historically marginalized groups.

Under the proposed changes, applicants and recipients of federal financial assistance would be required to sign new certifications under penalty of [criminal and civil law](#). These certifications attempt to align with President Trump's [executive order](#) and the [U.S. Department of Justice](#) guidance, which [misrepresent diversity, equity, inclusion, and accessibility](#) (DEIA) programs and activities as "illegal." The new certification also includes provisions on undocumented immigration and terrorism.

- 1. These proposed changes are contrary to federal law.** The executive branch does not have the authority to add across-the-board terms and conditions to any potential applicant. Nor does it have the authority to add terms that go beyond what Congress has authorized or federal law. In this case, the Administration is attempting to use the certification process to add terms and conditions that it cannot lawfully impose. Similar actions by other federal agencies have been blocked by federal judges as violating federal law or the U.S. Constitution.
- 2. The proposed changes are vague, making it nearly impossible for nonprofits to know whether they are in compliance. Many nonprofits would need to spend scarce resources to consult with attorneys just to understand what is required of them.** The revised certification does not define "diversity, equity, inclusion, and accessibility," or explain which executive orders are "relevant" and must be followed. The certification reaches a broad and predetermined conclusion that certain DEIA efforts are illegal, including those that have been upheld by courts or can be administered lawfully. While the certification requires compliance with relevant executive orders, those orders only apply to federal agencies, not other entities. The proposal requires nonprofits to certify that they will "not fund, subsidize, or facilitate terrorism or other illegal activities that threaten public safety or national

security.” However, it is unclear which activities the Administration believes are related to public safety or national security. Similarly, the proposed certification focused on undocumented immigration is unclear. Many nonprofits provide immigration legal services, humanitarian assistance to asylum seekers, or emergency shelter to migrants—all lawful activities. Requiring nonprofits to certify compliance imposes a significant cost and time burden on organizations and jeopardizes access to these services.

- 3. The proposed changes expose nonprofits to possible legal harassment.** Because the certifications are unclear and do not align with how courts have ruled, nonprofits will worry the administration and others may claim they are in violation of the certification for engaging in *lawful* activities, forced to spend staff time and resources defending themselves in investigations, audits, and court.
- 4. The proposed changes insert politics into federal programs.** The purposes of federal grant certifications are to discourage fraud and mismanagement of federal funds, and to ensure that recipients expend funds in a manner that is consistent with Congress's purpose in making those funds available, not to insert politics and ideology into the delivery of essential services. The proposed changes, however, open the door to this and future administrations changing grant certifications to advance policy outcomes they cannot achieve legislatively.
- 5. The proposed changes force nonprofits to choose between applying for critical community resources from the federal government and their deeply held values and beliefs.** Many nonprofits hold core values around advancing diversity, equity, inclusion and accessibility, welcoming immigrants, or opposing the Administration’s priorities or ideology. The proposed certification targets nonprofits with these viewpoints, forcing them to decide between these values and their ability to serve their communities through federal programs.
- 6. The proposed changes threaten civil and criminal penalties, deterring participation in federal programs.** By threatening personal criminal exposure, many effective and well-qualified nonprofits may decide it is not worth the financial and legal risk to apply for federal grants, especially if the certifications are unclear. They may reasonably choose to forgo federal funding rather than accept that risk. As a result, well-qualified, mission-driven nonprofits will be shut out of federal programs, harming the communities those programs were designed to serve.
- 7. The proposed changes undermine the effectiveness of federal programs and harms communities.** Without well-qualified grantees applying for and administering federal resources, the people and communities that rely on nonprofits and the essential services they provide will be harmed. Individuals may experience disruptions to life-sustaining support and services, and communities may suffer from increased poverty and hunger, alongside severe impacts to health, housing, and transportation systems.

We urge GSA to reverse course and stop these proposed changes.
