Dear Chair Hyde-Smith and Ranking Member Gillibrand:

As you consider the Fiscal Year (FY) 2027 Transportation, Housing and Urban Development, and Related Agencies appropriations bill, we urge you to support the Department of Housing and Urban Development's (HUD) Section 202 and 811 affordable housing programs for older adults and persons with disabilities.

We respectfully request:


- full funding for contract renewals for the Section 202 Housing for the Elderly program;
- an additional \$600 million for capital advances and operating subsidies for 2,000 new 202 homes to meet increasing need;
- \$50 million to fund a new Older Adult Special Purpose Housing Choice Voucher program for 5,000 older adults;
- \$10 million in Rental Assistance Demonstration conversion subsidy to support preservation of 3,000 Section 202 homes, with language ensuring all older adults in these properties keep their homes;
- \$265 million to renew and expand service coordinators in 202 housing;
- full funding to cover all renewals for Mainstream Housing Vouchers, Non-Elderly Disabled (NED) Vouchers, Section 811 Project Rental Assistance (PRA), and 811 Project-Based Rental Assistance Contracts;
- \$500 million for new Mainstream vouchers; and
- \$424 million for new 811 PRA awards.

Higher costs for housing, food, and other necessities have strained budgets for many older Americans on fixed incomes. According to the most recently available federal data, one in five people experiencing homelessness was aged 55 or older, and estimates suggest this segment of the homeless population could triple by 2030. Our request would help stem this crisis by creating a new Older Adult Special Housing Purpose Voucher program specifically to help low-income older Americans cover rising housing costs in the private market and in assisted living communities and increasing 202 housing funding to build more affordable housing for older adults. Together, these requests would ensure more older Americans have a safe, affordable place to live, both now and for the long-term.


Like older adults, Americans with disabilities are also facing growing housing stability challenges. The Urban Institute estimates that there are at least 18 million individuals with disabilities who are eligible for federal housing assistance but not receiving it. As the only federal housing programs dedicated to those with disabilities, HUD's Mainstream, NED, and Section 811 programs provide critical assistance that helps these Americans live independently while remaining connected to their communities. Without this funding, HUD reports that many of those served would be forced to live in an institution, unstably housed, separated from family or other caregivers, in a homeless shelter, or would have no housing options at all. Our funding requests will allow the Department to renew all current rental contracts and fund new Mainstream vouchers and 811 project rental assistance awards to expand affordable, accessible, and integrated housing for persons with disabilities.

HUD's Section 202, 811, and Mainstream and NED Voucher programs provide safe and dignified affordable housing for older adults and persons with disabilities. We encourage you to continue Congress's longstanding bipartisan support for these programs in FY 2027. Thank you for your consideration of these requests.


